#### 2.6 Punitive measure

The company shall treat all employees with dignity and respect. The Company shall not participate in or tolerate the use of physical punishment, mental or physical coercion and verbal abuse of employees, and shall not allow the treatment of employees in a rough and inhuman manner.

### 2.7 Working hours


The Company shall comply with local laws and industry standards regarding working hours and ensure that every employee has at least one day off after working six consecutive days. All overtime work must be voluntary.

### 2.8 Wages and salaries

The company shall ensure that wages paid in a standard working month meet at least the legal or industry minimum wage and meet the basic needs of employees, as well as provide some discretionary income, and shall ensure that wages are not deducted for any disciplinary purpose

### 2.9 Management system

The company has established a sound management system to ensure the full implementation of the Code
